"Mashreq Hotel Welcome Offer" is a special promotion for Invitation only credit card ("Card") customers (Cardholders) and is only valid and eligible for the new Cards issued in the United Arab Emirates ("UAE") by Mashregbank PSC ("Mashreg"/ "Bank").

Offer details: Hotel Welcome Offer

- All new Cardholders will be eligible for Mashreq Hotel Welcome Offer of AED 10,000 on their primary card post card activation.
- Mashreq Hotel Welcome Offer can be availed in the form of hotel booking of amount up to AED 10,000 or Cardholder can get 3 million Mashreq Vantage points (previously known as Salaam Points) equivalent of AED 10,000 credited into their CIF on request within 7 working days.

- Cardholder can book a hotel of any amount, but Mashreq will only cover one-time welcome
 offer amount of up to AED 10,000.
- Once hotel booking is done, concierge will charge the amount to Cardholder's Mashreq io credit card.
- Mashreq will post cashback (credit adjustment) to customer's card account up to AED 10,000 as fulfillment for hotel offer within 7 working days from the day of booking.
- If a Cardholder redeems a welcome offer by contacting the concierge and booking a hotel, they have the flexibility to modify the booking anytime. However, in the event of cancellation, the welcome offer will still be considered as utilized, and the cashback will be credited to the Cardholder's card as described above, if not already done.
- Regardless of the currency used for hotel booking, all amounts will be converted to AED
 according to the agreed conversion rate between Mashreq and the concierge. Additionally,
