- There is no minimum spend required to avail the offer.
- Any cashback credited by the Bank to a Cardholder's credit card under this offer will not
 be considered as a payment towards the statement balance due on their credit card.
 Cardholder will be required to make a payment for at least the minimum payment due
 billed to their credit card by the payment due date to avoid any late payment fee. the
 cashback will be adjusted against any subsequent spending made by them on the credit
